## BOLSTERING SUPPORT FOR CAPITAL CAMPAIGN Only \$300,000 Needed to Reach \$2 Million Goal!

Over the past year, our House Corporation board and capital campaign board have been working together to ensure that Beta Phi has many bright decades ahead. While you didn't hear from us in the spring, our diligence and dedication to Beta Phi has not wavered.

Now that we are so close to reaching our campaign goal, now is the time for us to give it all we've got—and the campaign board is doing just that. We believe we're in an even better position than we were a year ago, even despite the brief pause in our fundraising efforts. # FINDING A PLACE IN ΔΤΔ

## How Jeffrey Pelletier '94's Experiences Help Him Mentor the Next Generation

Joining Delta Tau Delta as an alumni initiate, **Jeffrey Pelletier '94** (Boston College) credits this decision to the simple fact that someone asked him to be a part of the fraternity. As there was no Greek life at Boston College, this was Jeff's first opportunity to be a part of a fraternity. He began working with the Delt colony at Ohio State in 2004 as a university staff advocate, and the colony members liked Jeff enough to give him a bid to join as an alumni initiate. "I was honored to go through the initiation ceremony with the rest of the founding classes when they rechartered in 2006," he shared.

ΔΤΔ was one of two fraternities expanding on campus that fall. "After reading through their mission statements and values, the way that ΔΤΔ articulated what it meant to be a member stood out to me," Jeff recalled. He also had a good friend and colleague who recolonized a chapter at his own undergraduate institution just a few years before, so his influence definitely tipped the scales for Jeff to want to work with Delt.

Before coming to Ohio State for graduate school in higher education and student affairs, Jeff was an officer in the U.S. Navy and a government contractor for the Navy. "I always knew I wanted to work on a college campus, after having a positive experience through my own involvement as an undergraduate," he shared. "It just took the right combination of people to encourage me to just make it happen."

Jeff believes working with undergraduates and advising helps him in his day-to-day work with his staff, students, and volunteer work with other professional organizations. "It also gives me a chance to advocate for the positive aspects of the fraternity experience, when inexperienced people start speaking poorly based solely on what they may see in the news," he explained. The most rewarding part for Jeff is knowing that his team is making an impact on the lives of those who use their facility every single day.

As for current undergraduates, Jeff advises them to take some time to ask themselves important questions. These include, "What brings me joy? What am I good at? Where in the world is there a need for that? It takes time to arrive at the answers to those questions (maybe not even before you graduate), but the intersection of all three, if you're lucky, is where you might find your calling or vocation." He also urges them to think beyond themselves, both in everyday situations and wanting to save the world. "It's great to have aspirations, but it's also great to pick up after yourself, let a car merge in front of you, or use complete sentences in texts and email."

Although Jeff's Delt experiences have come solely as an alumnus, he always tries to tell active members of Beta Phi that they don't join for three to four years, they join for life. "If you think about it, you spend just a fraction of your time as a Delt as an active chapter member. The vast majority of your time is as an alumnus,"



he explained. "If not for the involvement of hundreds of alumni, our chapters would not be able to persist. Even though all of my time as a Delt has been as an alumnus, I can safely say that some of the most rewarding Delt experiences out there are ones that alumni can take part in."

Jeff's wife, Jen, also works at Ohio State in the Office of Student Life, in our Student Activities Department. Although their students keep them busy, they took up curling last year. They attend a club in Columbus not too far from where they live, and really like the people they've met there. "We love talking to people about it and getting people interested, and we even helped host a Delt alumni 'learn to curl' event last February."

## Why John Shave '89 Ensures the Lasting Legacy of Beta Phi



**H**aving gone through formal recruitment in the mid-'80s, **John Shave '89** was immediately drawn to Delta Tau Delta, especially the quality of the diverse individuals. "The bottom line is that the Delts were in a league of their own in terms of academics, Greek life, athletics, and epic social events—I was sold on the best fraternity at The Ohio State University," he recalled.

As CEO/entrepreneur/investor, John has always been the CEO and typically the founder/investor in his enterprises. "My gift is the ability to identify trends, deploy capital, and develop a winning culture of individuals that walk through

walls to execute the corporate mission." He began in 1992, selling telecom services to businesses in Chicago. After resigning in 1993 from MCI-Worldcom, John founded a telecommunications company, Globalcom, which he sold in a windfall exit in 2008. "In life we are always selling, and our confidence sets the tone for how we envision our potential," he shared. "Be confident, think big, be ethical, and good things will happen."

John's biggest challenge was learning how to navigate and succeed when monopolistic oppression by nemesis

AT&T relentlessly tried to put them out of business with regulatory pressure, deep pockets, and anti-competitive behavior. "We persevered, kept the course, and success followed." ## Russell "Brian" Stump '86 Shares the Importance of Giving Back

When Russell "Brian" Stump '86 arrived at The Ohio State University as a young man, he found the Greek system in full force. Over the summer, he met several guys through his job who were Deltas. "They invited me over and I obviously fell in love with what was going on and the social scene," he recalled. "It was something I'd never been exposed to growing up—it was the perfect fit."

Those years spent at the Shelter were too short, and Brian reminisces how every day felt like a vacation. "Starting about Thursday afternoon guys would be out on the front lawn just hanging out and drinking beer throwing the football. Just all good times." Delta Tau Delta gave Brian more than just good times, however. He also gained a sense of responsibility. "I think through the social aspect and learning how to deal and interact with people, I kind of blossomed," he shared.

Directly following graduation, Brian began working for a local Japanese-owned steel service center. He was in internal sales, and spent the majority of his time calling on existing clients. During this time, a Beta Phi brother working for John Hancock Financial Services showed Brian what he did, and Brian found the products and services he was offering intriguing. "Two months later I quit my job and got my insurance and securities licenses without knowing anyone or having any money," he remembers. Brian started with John Hancock in 1987 and in 2000 became the co-founder of Stump Bardash Gabel & Howard, a boutique wealth management and advisory firm, where he serves as managing partner today.

Since then, Brian has had the opportunity to witness the Beta Phi Chapter become even better over time. "Good friends of mine are on the House Corporation, and they said they're an outstanding group of guys," he shared. "I think the chapter is in good hands and on the right path for sure." For Brian, giving back to the *Beta Phi: Doorway of Opportunity* campaign was about paying it forward. "I felt a sense of duty and responsibility to make sure the tradition carries on," he explained. "It wasn't a question of whether or not I was going to give, it was just at what level."

Knowing how tough campaigns can be to get up and running, as well as how much the addition to the house cost, Brian knew it was the right thing to do. "Beta Phi holds a special place in my heart and I often look back at the memories from those days." Ensuring the Delt legacy at OSU continues for future young men is what the campaign is all about.

Brian has two children: Michael at OSU in the Fisher College of Business and Maddie at the University of Massachusetts studying Global Health Policy. Sadly, his college sweetheart and wife of 23 years, Chris Wilson Stump, passed away of pancreatic cancer in May of 2012. "She was my rock and I was madly in love with her. A lot of the guys would remember her." Brian continues running his business and making sure his children get out of college, and is enjoying life.

# Beta Phi a Top Three Fraternity in GPA

## Chapter Sets Philanthropic, Professional, and Academic Goals

The Beta Phi Chapter has been hard at work focusing on scholastic excellence, community involvement, and philanthropy. In my report I will outline for you how we've undertaken these pursuits to become leaders on campus in the classroom and community. While it is impossible to capture in this report the scope of the merit of our chapter, the Beta Phi men of Delta Tau Delta have been following the tradition of those before them; leading lives of excellence.

### SPRING REVEALS LARGEST NEW MEMBER CLASS

Our recruitment chairman, **Woody Truncellito '20**, has done an excellent job during his year tenure. In the spring, we had our largest recruitment of all time, as well as the largest on campus with over 300 participants. From this, we took one of the largest new member classes in Beta Phi history, the Beta Kappa class, with 37 initiated members. This fall, we had another successful recruitment, taking in 10 new members in the Beta Lambda class.

### THIRD AMONG IFC FRATERNITIES

As expected, the men of Beta Phi continued to be campus leaders in academics. Last spring, our chapter was ranked fourth among IFC fraternities with a cumulative GPA of 3.42, which is well above the Ohio State all-male Greek average, as well as undergraduate average. This fall, we moved up a rank into third place with a cumulative GPA of 3.44. This completed our goal as an executive committee to move into the top three fraternities GPA wise. In the spring, we also had 84 men on the Dean's List.

### \$20,000 CHARITABLE DONATION GOAL

I am proud to say that we ran a very effective semester of philanthropy last spring, overcoming

adversity along the way. Led by Philanthropy Chairman **Evan Raso '20** and Vice President External **Michael Bougie '19**, we executed three spectacular events. The first was a pairing with Buckeye Stand-Up Comedy Club to bring in Creed Bratton from *The Office*. This event raised over \$1,200 for JDRF. As a fraternity, we raised \$10,535 for pediatric cancer research at Ohio State's annual Buckeyethon event.

In April, despite our father's weekend philanthropy golf outing being canceled due to snow, we were still able to have a great charity dinner where we had a presentation from the Columbus JDRF office and rallied the chapter together to raise over \$1,000. This fall, we had a surprisingly lucrative T-shirt sale that raised over \$3,000 for JDRF and a walk team for the JDRF One Walk on September 30. We will be working on a month-long fundraiser in November, National Diabetes Month. Our philanthropy goal for 2018 is \$20,000 of charitable donations and we hope to work diligently this fall to hit that number.

### MEMBERS ACTIVE ACROSS CAMPUS

Though many of our members are actively involved in individual pursuits, last spring we had a number of members stand out amongst the crowd. **Ricky Mulvey '18** was very involved with The Ohio State University's Stand-Up Comedy Club, as well as a writer for the school newspaper, *The Lantern*. **Michael Berthold '19** continued his ongoing passion for music. **Andrew Hauer '21** won Alpha Phi's Mr. Ivy. **Colin Lippincott '18** won the Fisher College of Business's Rosenfield Family Prize for best security analysis. **Jimmy Karban '20**, **Brendan Burdett '18**, and **David Aslaner '19** are a part of College Mentors for Kids, which is a program aimed at leveraging natural connection as a student mentor with children to the opportunities of higher education.

In order to help us guide our chapter, we set three goals as an executive committee: climb into the top three in cumulative GPA among IFC organizations, increase philanthropy contributions to \$20,000, and provide road programs focused on skills after college.

As president, I am proud to have hit the first goal coming into this fall. As for the second goal, we are ambitious about closing the gap on \$20,000 of donations and believe it is more than possible. For the last goal, we look to provide another career-oriented networking event this fall. As the remaining time as an executive committee counts down, we believe we can hit our goals. We also look forward to the next leaders of the chapter to take the reins. As a chapter we want to thank the alumni one last time for all their contributions and unwavering support.


